# Rotadex Systems Limited: Modern Slavery Statement Issued pursuant to section 54 of the Modern Slavery Act 2015

### **Our Business, Structure and Supply Chains**

Rotadex Systems Limited is a manufacturing business employing around 42 people.

Rotadex falls outside the scope of the Modern Slavery Act 2015 but recognizes the need to ensure modern slavery does not exist in its Supply Chain. As such it takes a zero-tolerance approach to modern slavery and human trafficking.

The company works directly with customers and suppliers without the use of subsidiary companies. The Company operates predominantly in the UK.

The bulk of our raw materials (98%) are sourced from local or multinational businesses where the manufacturing processes are highly automated. These types of businesses are low risk and are all located in the UK. The highest risk areas pertaining to Modern Slavery in our supply chain are products with a high degree of labour content. We assess all suppliers and ask for information on quality standards and compliance with minimum wage laws and the working time Directive where applicable. We ask suppliers to complete the Modern Slavery Assess Tool and report on the Key Performance Indicators contained within the MSAT.

# **Due Diligence Processes for New and Existing Suppliers relating to Modern Slavery**

- 1. Mapping the supply chain to assess particular product or geographical risks.
- 2. Evaluating the modern slavery and human trafficking risks of each new supplier.
- 3. Completion of the Modern Slavery Assessment Tool.
- 4. Reviewing on a regular basis all aspects of the supply chain.
- 5. Taking steps to improve sub-standard supplier's practices.
